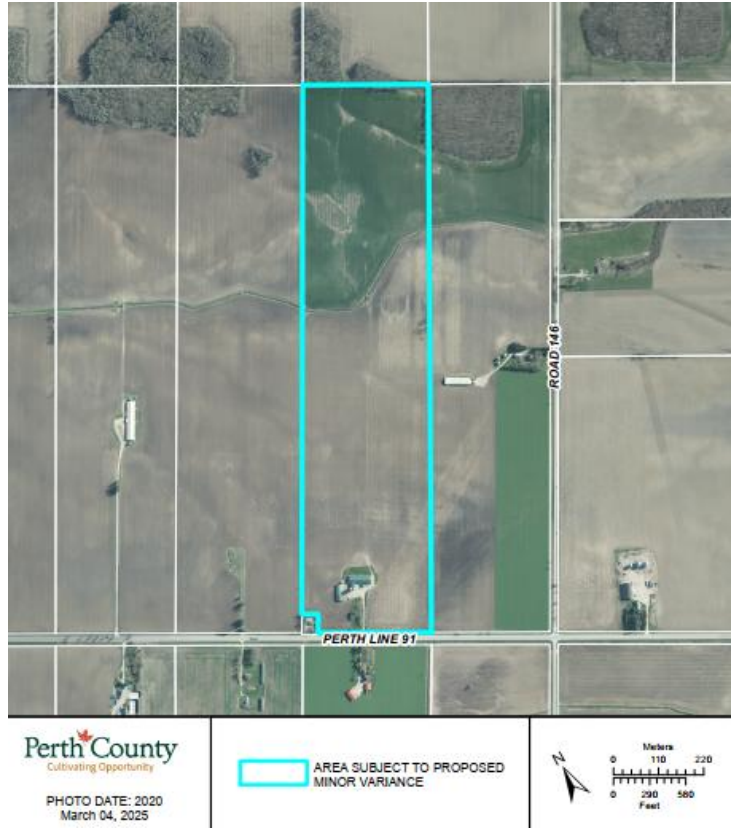
Public input on applications is invited. Pursuant to Section 45 of the *Planning Act*, the Committee of Adjustment for the Municipality of North Perth invites you to consider applications for minor variance and/or to forward written comments prior to the hearing.

**LOCATION OF PROPERTY:** Lot 8, Concession 11, Wallace Ward, Municipality of North Perth (5264 Line 91)

**PURPOSE OF APPLICATION:** To provide relief from Section 6.4.1 of the North Perth Zoning By-law of 49 m (160.8 ft) from the Minimum Distance Separation II (MDS II) calculated setback distance for a Type A land use; where 149 m (488.8 ft) is required and the applicant is proposing 100 m (328.1 ft) to allow for the expansion of a dairy barn operation.

If you are aware of any person interested in or affected by this application who has not received a copy of this notice you are requested to inform that person of this hearing.
