**PURPOSE OF APPLICATION**: The subject application is proposing relief from Section 11.2A.4(c) to reduce the minimum interior side yard width of an interior unit from 3 m to 1 m, relief from Section 11.2.3 to reduce the minimum front yard depth for an interior unit from 6 m to 4.5 m and relief from Section 11.2.2 to reduce the minimum lot frontage per dwelling unit from 6 m to 3 m. The proposed variances will facilitate the construction of eight (8) townhouse bungalow units on the property.
