**PURPOSE OF APPLICATION:** The subject application is requesting relief from Section 7.26 of the North Perth Zoning By-law to reduce the minimum requirement for rear yard depth from 7.5 m (25 ft) to 5.7 m (18.7 ft) to permit the construction of a covered deck at the rear of the existing dwelling.

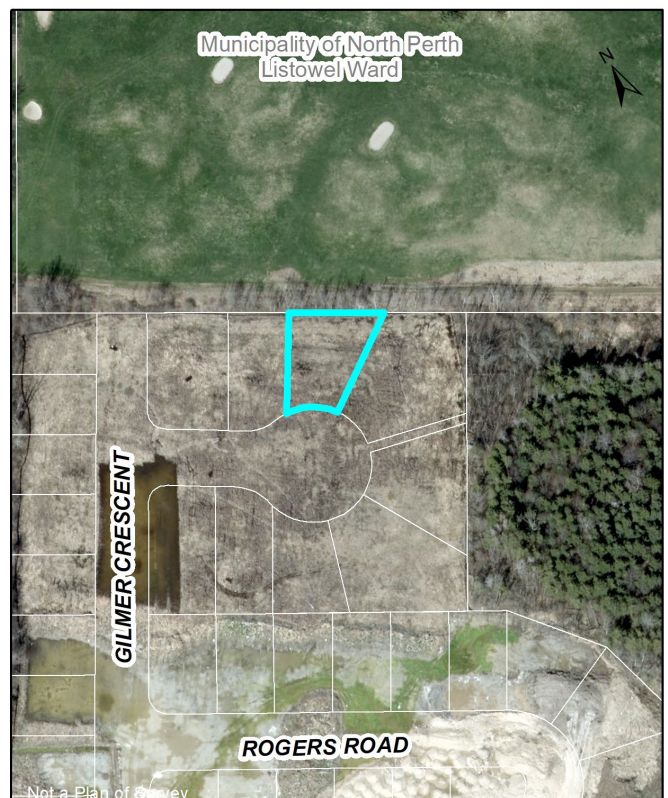
