PURPOSE OF APPLICATION:

The application for minor variance is requesting relief from Section 10.9.9 of the North Perth Zoning By-law to reduce the minimum rear yard depth from 7.5 m (25 ft) to 5.79 m (19 ft) to facilitate the construction of an addition to the rear of the dwelling.
